A Better Louisiana

We are helping Louisiana citizens get to work and helping Louisiana businesses meet workforce needs. Here are a few examples of laws that are allowing our Board to make an impact:

Pre-Application Eligibility Determination

The Pre-application Eligibility Determination Process is an optional program by which individuals with criminal records may submit information on their criminal conviction so as to obtain a determination of whether the criminal conviction disqualifies the person from obtaining a license from the LPTB. See, La. R.S. 37:33.

Welcome Home Act

Applicants are eligible to receive a license to work as long as they have held an out-of-state license at a similar scope-of-practice for at least one year, are in good standing, and have met the requirements of their initial licensing state. Veterans and service members are also eligible to apply using their military training qualifications. This is good for workers seeking to get back to work when they cross state lines, looks to attract talented workers into Louisiana, and allows licensing boards to quickly and efficiently compare out-of-state licenses to those in Louisiana using a license's scope of practice.

Servicemembers Civil Relief Act

This federal law requires state licensing boards to recognize professional licenses in good standing held by servicemembers and military spouses when they relocate due to military order. The reciprocating state may conduct a background check and issue a temporary license if it cannot issue a reciprocal license within 30 days.

Physical Therapy in Louisiana

PT Licensure Compact

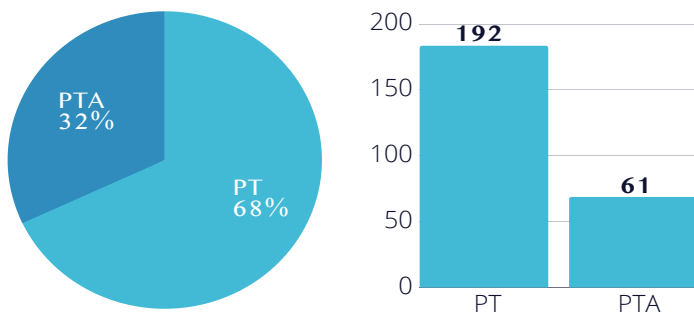
Physical therapists (PTs) and physical therapist assistants (PTAs) maintain a license in their home state (state of residence) and have the option to purchase a Compact Privilege to practice in other member states of the PT Licensure Compact, instead of holding multiple licenses.

MDS Survey Statistics

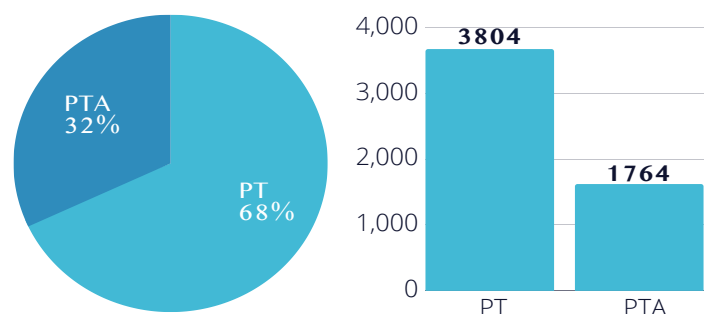
12.5% of total licensees are not actively practicing physical therapy.

Board Statement Regarding Imaging Referrals

In 2024, the board responded to questions providing guidance to licensees regarding imaging and physical therapists' ability to refer patients to a radiologist for appropriate diagnostic imaging studies. The Board stated in their written reply that nothing in the Louisiana Physical Therapy Practice Act, La. R.S. 37:2401-2425, nor the Board's Rules, LAC tit. 46: LIV §103 et seq., prohibits a physical therapist from referring a patient directly to a radiologist for appropriate diagnostic imaging studies.

Reference: La. R.S. 37:2418(B)(2)(b) & LAC 46: LIV Section 303.C.

2025 Licensure Renewal: FAQs

How many continuing education hours do I need to renew?

Unless exempted under §198, licensees must successfully complete, document, and report at least **30 hours** of board-approved continuing education courses or activities during the biennial renewal period. No carryover of hours is allowed. Continuing education will be credited in the reporting period in which the academic coursework, clinical instruction, tool, residency, or fellowship is completed.

Breakdown of Required Hours:

1. **Jurisprudence:** Minimum of 2 contact hours
2. **Ethics or Professionalism:** Minimum of 2 contact hours
3. **Clinical and/or Administrative:** Minimum of 26 contact hours

Renewal Process

Who is eligible to renew?

All licensees with an odd birth year and an expiration date of April 30, 2025.

When can I renew?

Licensees can access the renewal form starting February 1, 2025, and must renew by April 30, 2025. Renewal applications submitted in April are considered late and subject to a late fee.

What is the renewal fee?

Regular renewal fee: \$280 (covers two years, \$140/year).
Late renewal fee: \$400 (\$280 + \$120 late fee).

How do I access the renewal form?

Log into your dashboard at www.laptboard.org.

How can I verify that my license was successfully renewed?

Check the expiration date of your license on the Verify a License tool at www.laptboard.org.

Continuing Education

How many live/traditional continuing education hours are required?

None. As of 2021, live-hour requirements were removed. All 30 hours may be completed via board-approved online courses.

What course dates can I report during my 2025 renewal period?

Courses taken between February 1, 2023, and April 30, 2025, are eligible for reporting.

I took a course that is not board-approved. Can I submit it for approval?

Yes. The deadline to submit an individual course approval application is **February 28th of your renewal year**.

When can I begin taking CEUs for my 2027 renewal?

Coursework may begin on **February 1, 2025**. The same course cannot be reused across multiple renewal periods.

License Status Options

I do not want to renew my license. What are my options?

Go Inactive: Renew your license as inactive to avoid reporting CE hours.

Let it expire: If you no longer plan to practice in Louisiana, allow your license to lapse. No action or penalty is required. Once expired, you will be removed from Board communications.



Disciplinary Actions Report

Overview

This report provides case summaries of disciplinary actions taken by the Board against licensees in the calendar year 2024. It serves to ensure transparency and uphold professional standards within the practice of physical therapy. Cody R. LeBlanc, PT

(License #08870R), DeRidder, LA Case #2022-I-006 & #2022-I-009 Effective 01/31/2024 (Amended & Supplemental Order effective 02/27/2024)

LeBlanc committed violations including improper delegation, fraudulent billing, unprofessional conduct related to inter-office relationships, and inadequate documentation. His license is suspended for three years with a required Fitness for Duty and Psychosocial Evaluation by a Board-recognized provider, the live 3-day PBI Professional Boundaries and Ethics Course (Essential Edition) and the American Physical Therapy Association (APTA) documentation course. At the conclusion of the three-year suspension period, the respondent will be on probation for two (2) years. During the probationary period, the Board may make random unannounced monitoring visits to Respondent's work site.

Ashley A. Phillips, PT

(License #07848), Alexandria, LA Case# 2023-I-018 Effective 02/21/2024

Phillips self-reported a May 23, 2023, DWI conviction from an August 8, 2021, arrest, which was not disclosed during license renewal. Treatment records revealed nine relapses between November 2021 and August 2023. Her license is suspended until successful completion of a fitness-for-duty evaluation. Upon clearance, her license will be on probation for five years, requiring compliance with treatment recommendations and participation in the Recovering Physical Therapy Program.

Donna B. Redmon, PTA

(License #A7007), Alexandria, LA Case# 2023-I-060 Effective 02/21/2024

Redmon failed to renew her license in 2020 and 2022 and continued to practice with an expired license. Prior to reinstatement, she completed 60 hours of board-approved continuing education and met all reinstatement requirements. Upon reinstatement, her license was placed on probation for a minimum of two years.

Roderick R. Smith, PTA

(License #A4816), Shreveport, LA Case# 2023-I-036 Effective: 03/21/2024

Smith failed to maintain adequate treatment records and improperly treated patients without necessary reassessments. Smith also failed to disclose arrests and convictions (2001, 2008, 2018, 2022). He voluntarily surrendered his license, which has the effect of a revocation. He will be eligible to apply for reinstatement after five years, pending a fitness-for-duty evaluation. A hearing will determine his eligibility to return to practice, with possible requirements for remedial education and monitoring.

Latisha L. Williams, PT

(License #09078R), Shreveport, LA Case# 2023-I-056 Effective 03/21/2024

Williams failed to supervise appropriately, maintain records, reassess patients, or hold required patient care conferences. Her license is on probation for a minimum of two years, during which she will undergo random monitoring, complete specified ethics and documentation courses, and attend live jurisprudence sessions during renewal periods.

Jeffery R. Reeves, PT

(License #08293R), Covington, LA Case# 2024-I-004 Effective 04/17/2024

A complaint revealed Reeves consumed alcohol during work hours as Clinical Director. An inpatient evaluation recommended substance use treatment. Reeves voluntarily surrendered his license, which has the effect of revocation. He will be eligible to reinstate in five years after completing a fitness-for-duty evaluation and following recommendations. A hearing will determine his eligibility for re-licensure.

Angela C. Brewer, PTA

(License #A8915R), Shreveport, LA Case# 2022-I-023 Effective 04/17/2024 (Summary Suspension) & 05/15/2024

In April 2024, Brewer participated in a random drug screen as a Participant in the Recovering Physical Therapy Program. She tested positive for alcohol, which violated her prior agreement with the Board and her license was summarily suspended. In May 2024, the board suspended her license until she completed a relapse-prevention program and received a report from a board-recognized provider stating that she is safe to return to the practice of physical therapy with reasonable skill and safety to the public. Upon reinstatement, her license was placed on probation for five-years, which includes participating in the Recovering Physical Therapy Program.

Adam N. Casborn, Jr., PTA

(License #A7495), Birmingham, AL Case# 2023-I-035 Effective 06/12/2024

The Continuing Education Audit for the 2023 Renewal Period resulted in a finding that Casborn was non-compliant with continuing education requirements, resulting in a reprimand. He is subject to two subsequent renewal period CEU audits.

Elizabeth A. Haile, PTA

(License #A10789), New Orleans, LA Case# 2023-I-048 Effective 06/12/2024

Haile was arrested for a DUI in September 2023 and failed to report the arrest in a timely manner. Her license was suspended until she completed a fitness-for-duty evaluation. Following her suspension period, her license was placed on probation for five years with required participation in the Recovering Physical Therapy Program.



Disciplinary Actions Report

Jamie R. Floyd, PT,

(License #01920), Monroe, LA Case# 2024-I-005
Effective 07/24/2024

Floyd failed to report an August 11, 2023 arrest on her 2024 renewal application. The board suspended her license until she successfully completed all treatment recommendations following a fitness-for-duty evaluation. Following her suspension, her license was placed on probation for five years, requiring compliance with treatment recommendations and participation in the Recovering Physical Therapy Program.

Russell W. Hearne, PT,

(License #09007R), Vinton, LA Case #2023-I-009
Effective 08/15/2024

Hearne did not document the transfer of care or complete a discharge summary for patients he was assigned to from February 20, 2023 through February 24, 2023. His license is placed on probation for a minimum period of one year during which time he shall comply with random monitoring visits. Within the first six months of probation, he must complete PBI Education Medical Record Keeping Course.

Daniel J. Allemond, PTA,

(License #A8327), Lafayette, LA Case #2023-I-057
Effective 12/11/2024

Allemond engaged in unprofessional conduct related to inappropriate workplace communications with co-workers and co-professionals. Allemond's license is on probation for one year during which time he is required to complete individual psychotherapy with a Board-recognized provider. He is subject to monitoring visits and must present his consent order to his employer, direct supervisor, and any physical therapists, physical therapist assistants, or technicians he supervise or works for. He must also complete the PBI Education Professional Boundaries Course within the first 6 months of his probationary period.

Ryan S. Neill, PT,

(License #10956), Covington, LA Case #2024-I-015
Effective 12/11/2024

Neill failed to report to the Board behavior of a co-professional related to unprofessional conduct associated with alcohol consumption at the workplace. Neill's license was reprimanded and he is required to complete additional continuing education related to disclosure and duty to report.
